



Privacy Policy

What information does MVCC collect?

MVCC only collects personal information from you on a voluntary basis. When you submit personal information to MVCC, it will usually take the form of: (1) Web site registration; (2) customer service; (3) use of a website or other online. The information we collect may include personal information such as your name, e-mail address, phone number, and home address. We may also obtain information about you from other sources, as far as such other sources are legally entitled to share such information, and combine that information with information we have collected from you.

What are "Cookies" and does MVCC use cookies, track IP Addresses, or use other passive means to collect information?

MVCC uses cookies on its websites. A "cookie" is a small bit of record-keeping information that many websites and other online properties often store on a user's computer or device in order to anonymously identify it and associate activity with it. Cookies typically do not include people's names, or e-mail addresses.

With whom does MVCC share my personal information?

MVCC does not share or sell your personal information with outside third parties for those third parties to use for their own purposes without your agreement. MVCC discloses personal information only in accordance with this Privacy Policy with other third parties as necessary to complete any transaction through our websites or other online properties. Notwithstanding, you agree we may disclose personal information in the good faith belief that we are required to do so by law, including but not limited to disclosure to law enforcement or other government officials in connection with an investigation of fraud, intellectual property infringements, or other activity that is illegal or may expose you or us to legal liability. In addition, in the event of a merger, acquisition, reorganization, bankruptcy, or other similar event, MVCC customer information including personal information may be transferred to our successor or assign.

Your Privacy Rights

Does MVCC collect personal information from children under 13?

What safeguards does MVCC use to protect my personal information?
